Fee Regulations

for the Continuing Education Master's Programme „Humboldt Master of Laws“

According to § 17, Paragraph 1, Item 3 of the Constitution of Humboldt University of Berlin from October 24, 2013 (Official Bulletin of Humboldt University of Berlin No. 47/2013), the Faculty Council of the Faculty of Law enacted the following fee regulation for the international continuing education master's programme Humboldt Master of Laws on June 13, 2024*:

§ 1 Scope of Application

This regulation governs the collection of fees for participation in the international continuing education master's programme Humboldt Master of Laws.

§ 2 Fee Liability, Amount of Fees

(1) Fees of €7,500 per semester and per student will be charged for participation in the international continuing education Master's programme Humboldt Master of Laws. In addition to the fees mentioned in sentence 1, general fees and contributions, in particular semester fees, student body contributions, contributions for the student union, and the semester ticket will also be charged.

(2) The fees specified in paragraph 1, sentence 1, will not be charged for periods during which the participant is on leave of absence and has waived the taking of exams, including supervision of the thesis.

(3) The fees specified in paragraph 1, sentence 1, may be deferred, reduced, or waived if payment would constitute a financial hardship for the participant. Decisions under sentence 1 are made by the Dean of the Faculty of Law upon request of the participant for the duration of one semester. The participant must credibly demonstrate their financial situation.

(4) The fees specified in paragraph 1, sentence 1, may be reduced or waived if the participant applies for exmatriculation during the semester due to unforeseen circumstances, provided that the reduction or waiver is reasonable in light of the progress of the

semester and the financial situation of the participant. Paragraph 3, sentences 2 and 3, apply accordingly.

(5) The Faculty of Law supports participants in obtaining scholarships.

§ 3 Payment, Refund of Fees

(1) The fees specified in § 2, paragraph 1, sentence 1, are due for the first and second semesters upon the declaration of acceptance of the study place.

(2) If Humboldt University of Berlin is unable to offer admission to the program because the program cannot be cost-effectively funded due to insufficient participant numbers, any fees already paid in accordance with § 2, paragraph 1, sentences 1 and 2, will be fully refunded.

(3) If the participant is granted a leave of absence and submits a written declaration that they waive the taking of exams, including supervision of the Master's thesis, for the duration of the leave (§ 2, paragraph 2), any fees already paid in accordance with § 2, paragraph 1, sentence 1, will be refunded for the period of the leave of absence.

(4) If the participant is granted a deferral, reduction, or waiver (§ 2, paragraph 3 or 4), any fees already paid in accordance with § 2, paragraph 1, sentence 1, will be refunded in the amount of the deferral, reduction, or waiver.

§ 4 Use of Fees

The fees specified in § 2, paragraph 1, sentence 1, are exclusively used to finance the international continuing education Master's programme Humboldt Master of Laws in a cost-covering manner.

§ 5 Entry into Force

(1) This fee regulation enters into force the day after its publication in the Official Bulletin of Humboldt University of Berlin.

(2) This fee regulation applies to all students who commence their studies after the entry into force of this regulation, or who continue their studies following a change of university, program, or subject, or after re-registration.
